Thank you for purchasing a CHIMENTO ORO jewellery item. This is provide you with information regarding the processing of your personal data by Chimento Oro S.r.l. as per Art. 13 of Regulation (EU) 2016/679 (below "GDPR").

Data Controller: The Data Controller is Chimento Oro S.r.l. (Tax Code and VAT IT03994560245), with registered office in Via XX Settembre 48, Camisano Vicentino, Vicenza, Italy; e-mail info@chimento.it, certified email: chimentoorosrl@pec.it, herein "**Data Controller**"

Purpose and legal basis of the data processing

Your personal data will be processed for the following purposes:

- a) to allow the activation of the theft policy for the Chimento Oro jewellery item you have purchased, and the management of any claims reported by you (as per Art. 6, para. 1, letter b) GDPR);
- b) your prior consent to the sending of periodic newsletters and/or other commercial communications regarding the products, new services and initiatives of Chimento (as per Art. 6, par. 1, letter a) GDPR).

These processings will be based on principles of correctness, lawfulness, transparency and necessity, to protect your privacy and rights.

Data-retention times

Your personal data collected for the purposes referred to in letter a) above will be kept for the duration of the policy, for the time necessary for the management of any claims reported by you and, in any case, for the time necessary for the lapse of the statute of limitations of reciprocal rights.

The data collected for marketing and/or advertising purposes only will be stored until revocation of consent, or until the end of 24 months after the last contractual relationship with you.

Nature of data provision and consequences in the event of refusal

The provision of data is mandatory in order to fulfil legal and contractual obligations. Therefore, any refusal to provide them, in whole or in part, may make it impossible to validate the contract.

The providing of data for marketing and/or advertising purposes is optional and you may, at any time, withdraw your consent to the processing of such data so that you will not be informed of the commercial and/or promotional initiatives of Chimento.

Processing methods

Your personal data will be processed both by IT tools and manually, with appropriate methods and tools to ensure maximum security and confidentiality.

Categories of recipients

For the purposes specified above, your personal data will be processed by the Data Controller's staff specifically authorised to do so by reason of the tasks and according to the profiles assigned to them, as well as communicated:

- to public, judicial, and administrative authorities in compliance with specific legal obligations;
- to the insurance institutions that provide the policy;
- to third parties that carry out activities and services on behalf of the Data Controller, designated, if applicable, as External Data Processors as per Art. 28 of GDPR (such as, by way of example only and without limitation: accountant, legal professionals, communications companies, etc.);

Your personal data will not be subject to dissemination or automated processes aimed at profiling.

Transfer of data to a third country and/or an international organisation

Your personal data may be transferred to countries outside the European Union.

Rights of interested parties.

The rights provided by EU Regulation 2016/679 (Articles 15-21) are: the access, rectification, cancellation or restriction of data processing (if the conditions are met), opposition to processing; portability in the cases provided for in the Regulation; the revoking of consent.
